- - Such term as "Applicant" used in these rules and regulations are referring to the person applying for entrance into the Pageant.
- Such term as "Winner" used in these rules and regulations are referring to the person who has applied for entrance, paid the entry fee, was accepted as a participant, and won.
- Applicant must be a naturally born female in order to compete in the Pageant.
- Applicant must reside within the United States in order to compete in the Pageant.
- Applicant understands that she must compete for the title of Diamond Queen. Female, Must be within 30 – 75 year old, (single or unmarried, divorced, widowed, never been married),
- Resident of Texas
- Applicant understand that the ENTRY FEE in the amount of \$100.00 must be paid with the submission of the Pageant Application and becomes their application fee for membership in the NTAACA
- Applicant understands that the ENTRY FEE is non-refundable and non-transferrable; and must be paid in full before she can compete in the Pageant.
- Applicant understands that her entry fee includes entry into to the pageant and includes her crown and sash prize package for the title of which she wins for.
- Applicant understands that her crown and sash package will be part of the package to be won
- Applicant understands that she must compete in the two main areas of competition in order to be selected as a y Pageant winner; which includes the FUNDS RAISED and the PERSONALITY
